### TENDER DOCUMENT CHAPTER - I

## INSTRUCTIONS TO THE FIRM/ AGENCY

- 1.1 The Directorate of Geology, Odisha, Bhu-Bigyan Bhawan, Unit-V, Bhubaneswar-751001, invites Sealed Tender on behalf of the Governor of Odisha, in two bid system (Technical bid and Price bid) from reputed Firms/ Agencies, fulfilling the eligibility criteria to take up mineral exploration as per UNFC classification for "G-3 Level Mineral Exploration for Manganese ore, under NMET, initially and likely to be upscaled to G-2 Stage, at Hardatal Block, in Balangir district of Odisha" as per details in Chapter-III, during the year 2022-2023.
- 1.2The Firm/ Agency has to cover all aspects of the G-3 Stage Mineral Exploration of the assigned block as stated in Chapter-III. Bid for a part the aspects as in Chapter-III, shall be rejected in the tender process.
- 1.3 The Firm/ Agency shall obtain necessary forest clearance for Exploration work/ drilling work on behalf of the Directorate of Geology, Odisha for uninterrupted exploration operation, if necessary.
- 1.4 Initially 8 boreholes will be drilled. The average depth of inclined borehole shall be 70m ± 20% and the actual depth of each borehole may vary as per technical requirement for an approved quantum of drilling of 560m.
- 1.5 The Firm/ Agency have to undertake the following ancillary works.
- 1.5.1 Survey for location of borehole points as per approved plan or as advised by the Authorized Officer of the Directorate of Geology, Odisha.
- 1.5.2 Measurement of Co-ordinates of Boreholes, RL of Boreholes, drawing of the profiles along each completed borehole section and contouring of whole exploration block with 4 m contour interval by way of field survey, in Total Station instrument.
- 1.5.3 Drawl and processing of drill core samples at 1m interval or as advised by the Authorized Officer of the Directorate of Geology, Odisha.
- 1.5.4 The exploration work shall be executed as per specifications outlined in Chapter-III, under supervision of the Authorized Officer of the Directorate of Geology, Odisha.
- 1.5.5 The Firm/ Agency have to liaise with local for manpower engagement and other local problems if any for the purpose.
- 1.6 Firm/ Agencies are advised to visit the area at their own interest and expenses to assess the terrain conditions before submission of their offer.
- 1.7 Submission of Sealed Tender shall be deemed to have been done after careful stody and examination of the requirement indicated in the Tender document.

# CHAPTER - II GENERAL TERMS AND CONDITIONS

#### 2. ELIGIBILITY CRITERIA

- 2.1 The Firm/ Agency must be a Registered Company/ Registered Firm/ a Proprietary Concern/ a Body of like nature for Exploration work.
- 2.1 The Firm/ Agency must be capable to take up mineral exploration as per UNFC/ MEMC Rule 2015, Norms/ recommendation of the TCC-NMET, at "G-3 Level Mineral Exploration for Manganese Ore, under NMET initially and likely to be upscaled to G-2 Stage, at Hardatal Block, in Balangir district of Odisha" in future.
- 2.2 The Firm/ Agency must have successfully executed such exploration work with core drilling work of minimum 1000m in any Iron/ Manganese ore Prospect/ similar formations in Odisha/ India, in any one of the five preceding financial years (including the financial year 2021-22). In Technical Bid the bidder has to submit the details of Work Experience with Seal & Signature and supporting documents.
- 2.3 The Firm/ Agency must have minimum annual turn-over of Rs.1.5 Cr. (One Crore 50 lakhs) in any one of the five preceding financial years, including the financial year 2021-22. Audited Balance sheets in support of turn-over should be submitted.
- 2.4 The Firm/ Agency must have its own GST Registration/ Service tax Registration Number, PAN, EPF Code, ESI Registration Certificate, Labor license etc. and it should furnish the clearance certificate of GST & IT to this effect.
- 2.5 The bidder shall furnish EMD amount @3% of the estimated cost shown in the table 1.1 in Chapter-III.
- 2.6 The Firm/ Agency must not have been adjudged by any Court of Law or not blacklisted by any Govt. and any other authority. The Firm/ Agency have to submit an original Affidavit sworn in before an Executive Magistrate/ Notary Public to that effect with Technical Bid document.

#### 3 TECHNICAL BID WITH MADATORY DOCUMENTS

The Technical Bid shall contain the following documents in a sealed cover with an Index & Page No. (Annexure- III)

- 3.1 Filled in Bid Submission Check List as in Annexure-III, with the required supporting documents.
- 3.2 Tender processing fee of Rs.8260.00 (Rs.7,000.00 + GST @18% Rs.1260.00) in shape of DD drawn in favour of Director of Geology, Odisha, at any Nationalized Bank, payable at Bhubaneswar.

- 3.3 The Bidder shall have to deposit the "Bid Security Declaration" (Annexure-I) in accordance with the O.M. No.-8943/F, dt.18.03.2021, modified with No.-4710/W, dt.12.04.2022, duly signed with the stipulation that "if they withdraw or modify their bids during period of validity etc. they will be suspended for the time specified in the tender documents".
- 3.4 Declaration to the effect that the Price quoted by the Firm/Agency/ Bidder is not exceeding the approved unit rate of NMET, in any circumstances. (Annexure-II)
- 3.5 Affidavit sworn in before an executive magistrate/ Notary public to the effect that Firm/ Agency must not have been adjudged by any Court of Law or not blacklisted by any Govt. and any other authority.
- 3.6 Profile of the Firm/ Agency showing general details.
- 3.7 Power of Attorney/ Authorization by the Firm/ Agency in favour of the Person signing the Sealed Tender documents.
- 3.8 Proof of necessary mandatory documents/supporting/evidence substantiating the Tender short listing criteria i.e. GST Registration Certificate, PAN, EPF & ESI Registration Certificate, labor license etc.
- 3.9 Financial details of the Firm/ Agency as proof of Turnover i.e. Audited Financial Statements of three preceding financial years, including the financial year 2021-22. IT Return for last three consecutive years need to be furnished. If IT Returns for 2021-22 has not yet processed then the preceding 3 years need to be annexed.
- 3.10 Proof of Manpower and Details of Exploration Machines and other ancillary equipment to be deployed & Strength to execute the assignment.
- 3.11 Proof of relevant experience for preceding 5 years including the financial year 2021-22, in conducting such assignment. The Work Completion Certificate issued by Competent Authorities need to be provided with the Sealed Tender.
- 3.12 Tender Document forms a part of the Agreement. The Tender Document signed by the Firm/ Agency on each page with seal as acceptance to the terms and conditions spell out in the Sealed Tender Document must be attached.
- 3.13 Other document if any as described for evaluation purpose.
- 4 PRICE BID
- 4.1 The Firm/ Agency has to quote its offered Unit Price / Rate item wise, for all items shown in Chapter-III, not exceeding the approved unit rate of NMET, in any circumstances. The offered Price Contract/ Rate will be calculated item wise. Accordingly the Cumulative Contract Value of the bidder shall be detected.
- 4.2 The Offered Unit Price/ Rate must be shown with Basic Price which is inclusive of all other taxes, levies, duties, transportation & incidental charges, etc. + GST it any to be mentioned separately.

4.3 The Cumulative Contract Value/ Offered Price thus arrived shall be taken for comparison to find out the L1 Firm/ Agency, for issue of Contract/ Work Order.

#### 5 PROCEDURE FOR SUBMISSION OF EOI / SEALED TENDERS

- 5.1 Interested Firms/ Agencies are required to download the Tender Document from the departmental Website http://www.orissaminerals.gov.in
- 5.2 Technical Bid and Price Bid duly filled-in, in the prescribed format are to be sealed properly in separate covers, Super-scribed as "TECHNICAL BID" and "PRICE BID". Both the sealed covers shall be put in a third sealed cover, Super-scribed as the "Tender for "G-3 Stage Mineral Exploration for Manganese Ore at Hardatal Block" and to be submitted to the Director of Geology, Odisha, Bhu-Bigyan Bhawan, Unit-V, Bhubaneswar-751001, so as to reach latest by 5.30 P.M. on 12.08.2022 by Regd. Post/ Speed Post/ Courier Service only.
- 5.3 The Sealed Tenders received after the aforesaid time and date will not be opened and will be the asset of the Director of Geology, Odisha.

## 6 EVALUATION PROCESS/ OPENING OF THE SEALED TENDER

- 6.1 The Evaluation Process shall be undertaken by a Committee constituted for the purpose by the Government, on a scheduled date, wherein the bidders or their authorized representatives may remain present on production of their identity/ authorization on demand.
- 6.2 The Sealed Tenders shall be opened in presence of the designated Committee. Then the Technical Bids shall be opened for evaluation by the Committee or by an ancillary Technical Evaluation Committee constituted for the purpose.
- 6.3 The Technical Evaluation Committee may ask for a Presentation of the "Technical Credentials" (As per Para-3) submitted by the Firm/ Agency/ Bidder with their Technical Bids, on a day, communicated or noticed to them.
- 6.4 On recommendation of the Technical Evaluation Committee (TEC), the Firms/ Agencies/ Bidders qualifying in the Technical Parameters as stated in Para-3, shall be declared as Qualified Bidders for opening the Price Bids/ Price Contract.
- 6.5 The Price Bids/ Price Contracts of the qualified Bidders shall be opened only, in presence of the designated Committee and the Price Bids/ Price Contracts of the disqualified bidders shall be kept unopened.
- 6.6 The comparison of price shall be made among the qualified Firms/ Agencies/ Bidders on their offered Cumulative Total Value as per Para-4 and the Firm/ Agency/ Bidder offering the lowest value shall be declared as L-I bidder, of the Tender process.

#### AGREEMENT/ CONTRACT

7.1 The L-1 Firm/ Agency/ Bidder shall be asked to enter into a written Contract/ Agreement with the Director of Geology, Odisha on the above work in Non-judicial stamp paper of appropriate value within Seven days from the date of issue of the offer letter, in conformity to Para-6 & Para-8, failing which, appropriate action including termination of the offer will be taken up by the Director of Geology, Odisha.

#### 8 PERFORMANCE SECURITY DEPOSITS

- 8.1 The qualified Firm/ Agency shall require to submit Performance Security @ 3% of Total Cumulative Contract Value calculated as per Para-4, rounded up to the next 100, in shape of Bank Guarantee in favour of Director of Geology, Odisha (Vide O.M. No.-8952/F, dt.18.03.2021 and modified vide O.M. No.-4719/W, dt.12.04,2022) within 10 days and to sign a Contract/ Agreement, accepting the offer.
- 8.2 The Performance Security shall remain valid for a period of 60 days beyond the contract period and be further extended if so required by the Directorate of Geology, Odisha. (vide O.M. No.-27928/F, dt.16.10.2020)

#### 9 ISSUE OF WORK ORDER/ CONTRACT ORDER

9.1 On receipt of the written Contract as asked in Para-7 and Performance Securitry as asked in Para-8, Work Order/ Contract Order shall be issued in favour of the L-1 Firm/ Agency/ Bidder, stating to commence the exploration work within 10 days from the issue of Work Order.

#### 10 STIPULATED TIME PERIOD

- 10.1 Validity period of the Contract: The Validity period of the contract shall be 150 days from the date of award of the contract.
- 10.2 The agency shall commence the exploration work within 10 days of issue of the work order.
- 10.3 The total quantity of Exploration work should be completed within schedule time period as mentioned in Column-7, of the Table in Chapter-III, from the date of issue of work order.
- 10.4 The agency shall make all necessary arrangements for commencement of the exploration work in strict adherence to the specifications, terms and conditions of the Tender Document & NMET guidelines and complete the work within the stipulated of time.

#### 11 OTHER TERMS & CONDITIONS:

11.1 The Firm/ Agency is not allowed to subcontract, outsource, sub-let or assign the contract and scope of services, either partly or wholly, without the written approval of the designated officials from DG(O) for the services for which such subletting is

- sought. However, the DG(O) reserves the full right to refuse any such approval to the Firm/ Agency without assigning any reasons thereof or rationale for such decision. Provided, nevertheless, that any such consent shall not relieve the Firm/ Agency from any obligation, duty or responsibility under the Contract Order / Agreement.
- 11.2 It shall be the Firm/ Agency's responsibility to set up the camp for providing necessary accommodation to its exploration personnel nearest to the exploration site. Management of the camp affairs, providing logistic support including supply of water to the exploration personnel at camp shall be the responsibility of the Firm/ Agency.
- 11.3 Preparation of approach road for mobilization of men and machinery to the exploration site and other required materials shall be the responsibility of the Firm/ Agency.
- 11.4 The Firm/ Agency is to take up the exploration work as per the direction of the concerned Authorized Officers of the Directorate of Geology, Odisha and is answerable to them.
- 11.5 The exploration should be undertaken as per the quantum and time period indicated in Chapter-III (Schedule and scope of work & Specifications) and General Terms & Conditions contained in this document. Any deviation to the same without written consent of Director of Geology, Odisha, will lead for termination of the contract or cancellation of the particular item of exploration under contract. However, depending upon the field conditions, Director of Geology, Odisha reserves the right of changing the technical parameters in case of requirement.
- 11.6 The Firm/ Agency, after setting up the Camp at the exploration area, need to take up the Topographic Survey/ Magnetic Survey immediately after setting up the camp. The Topographic Survey should be completed within a period 45 days and Magnetic Survey need to be done within 15 days.
- 11.7 Magnetic Survey Report needs to be submitted within 7 days of completion of Magnetic Survey, based on which Boreholes will be fixed.
- 11.8 The Site-in-Charge of the agency shall submit the daily, weekly and monthly progress report of the exploration work to the Authorized Officer of the Directorate of Geology, Odisha. A copy of monthly progress report must be forwarded to the Director of Geology, Odisha, within first week of succeeding month by the agency, duly certified by the Authorized Officer of the Directorate of Geology, Odisha.
- 11.9 In case the agency fails to achieve the desired specification or abandons a Boresole George before the required depth, another Borehole adjacent to the incomplete Borehole would be taken up at the cost of the Firm/ Agency, as directed by the Authorised

Officer of the Directorate of Geology, Odisha and No cost for the incomplete Borehole shall be paid by the Director of Geology, Odisha.

- 11.10 The Core /Sludge should be collected with utmost care at the time of exploration and shall be preserved in properly partitioned G.I. / Plastic core boxes (to be supplied by Agency) with necessary labeling of the runs under the direction of the Authorized Officer of Directorate of Geology, Odisha. Details of the borehole, box number, length of core etc. are to be written on the outer and inner side of the core boxes. The core boxes are to be delivered at the place as specified by the Authorized Officer of the Directorate of Geology, Odisha. The cores & the core boxes need to be collected and preserved as per the guidelines issued by NMET.
- 11.11 Necessary field survey work required for locating the Boreholes on the ground as per the supplied approved plan, measurement of the co-ordinates, RL of the completed Boreholes, contouring at 4 m interval and profile of each drill section etc. shall be done by the agency as per the advice of the Authorized Officer of the Directorate of Geology, Odisha.
- 11.12 A register is to be maintained at exploration site (rig-wise) on daily basis to record bore hole wise / run-wise exploration logs, indicating the size of core barrel/casing used, the percentage of core recovered and the process of core exploration (dry/wet) for convenience of supervision and preparation of summarized log with above data (borehole wise). Summarized logs in respect of completed Boreholes with abstract of above data must be submitted to the Director Geology, Odisha duly certified by the Authorized Officer of the Directorate of Geology, Odisha along with the claimed bill of the agency.
- 11.13 As and when required before certification/ counter signature, if necessary, random inspection may be undertaken with the deployment of departmental officers. However, irrespective of the pre-audit as and when required the certification of documents must be countersigned by the Accounts Officer for the claim of the bill by the agency. In that circumstance the service provider/ Firm/ Agency shall extend logistic support to them.

#### 12 RESPONSIBILITY OF THE FIRM/ AGENCY

- 12.1 The Firm/ Agency will submit necessary Statutory Returns as applicable to respective quarter under intimation to the Authorized Officer of the Directorate of Geology, Odisha.
- 12.2 The Firm/ Agency will provide all safety equipments to the workers and take necessary measures for safety.

- 12.3 The Firm/ Agency will provide necessary medical facilities to its workers and provide drinking water at its own cost.
- 12.4 The Firm/ Agency shall report immediately to the Authorized Officer of the Directorate of Geology, Odisha in case of any major or minor accident to his worker or staff.
- 12.5 The Firm/ Agency shall be liable for payment of compensation to workers under Workmen's Compensation Act-1923. Any such claim by the workers shall be deducted by the Directorate of Geology, Odisha from the Firm/ Agency's dues.
- 12.6 The Firm/ Agency will make all necessary arrangements for commencement and carrying out of the exploration work by its own resources in accordance to the specifications, terms and conditions indicated herein.
- 12.7 Utmost care will be taken by the Firm/ Agency to preserve the recovered cores and sludge in G.I. Core Boxes and deliver the same at the place as specified by the Authorized Officer of the Directorate of Geology, Odisha. The core boxes are to be provided by the Firm/ Agency.
- 12.8 Concrete pillars are to be constructed on field survey points and on the completed Boreholes with details/ references written on the concrete pillars indicating the borehole number, location Co-ordinates and RL under the guidance of the Authorized Officer of the Directorate of Geology, Odisha.
- 12.9 The Firm/ Agency will deposit GST relating to this work regularly and submit proof of the deposit to the Director of Geology, Odisha.
- 12.10 The Firm/ Agency shall provide all logistic support to the officials of DG(O) associated with the Project and also to the Inspecting Officials as and when deployed.

## 13 RESPONSIBILITY OF THE DIRECTORATE OF GEOLOGY, ODISHA

- a. The Authorized Officer of the Directorate of Geology, Odisha will show the area and help locating the Boreholes as per the approved plan or as advised by the Director of Geology, Odisha.
- b. The Authorized Officer of the Directorate of Geology, Odisha, is authorized to verify all the Statutory Records/ Returns of the Firm/ Agency.
- c. The format for daily as well as weekly progress report of the exploration work / drilling work shall be provided by the Authorized Officer of the Directorate of Geology, Odisha.

#### 14 AUTHORISED OFFICER/ REPRESENTATIVE

a. Any officer in the rank of Geologist or higher shall be declared by the Director of Geology, Odisha, as the Authorized Officer to supervise the exploration work/ drilling work & any allied works assigned to the Firm/ Agency. Besides, Director

- of Geology, Odisha may nominate additional officer(s) under his control to assist the declared Authorized Officer as per requirement.
- b. The Firm/ Agency will declare the name and designation of its site representative who shall be responsible for execution of the work and will act according to the instruction of the Authorized Officer of the Directorate of Geology, Odisha.

#### PENALTY:

Penalty shall be imposed as below.

- a. In case the Firm/ Agency fails to start the work within 10 days of issue of the Work order/ contract Order, the contract shall be terminated along with forfeiture of the Performance Security submitted in shape of Bank Guarantee, at the decision of the Director of Geology, Odisha.
- b. In case the Firm/ Agency fails to achieve target within the stipulated time limit & contract period, penalty @20% of the Bill amount shall be imposed.
- In case of delay and/or shortfall in achievement of target caused due to reasons beyond control of Firm/ Agency, penalty may be waived subject to approval of the Competent Authority.

#### 16 TERMS OF PAYMENT:

#### 1.2 ADDITIONAL SPECIFICATIONS:

The core exploration work shall be taken up by the Firm/ Agency as per following specifications:

- a. Size of Borehole : 76 mm (minimum).
- b. Inclination of Borehole : The Boreholes shall be at angle 45° w.r.t. horizontal boreholes. No deviation or drift unless otherwise required. BH deviation study, need to be done periodically.
- c. Number of Rigs: The party should possess minimum two high Capacity Mechanical/ Hydrostatic rigs of reputed make capable of exploration boreholes up to 100m (Av) depth in the hard formations.
- d. Formations to be drilled : Soil, Laterite, manganeferous laterite, manganese ore, calcgranite, quartzite, granite gneise variants, khondalites etc.
