PROCEEDINGS OF THE MEETING ON DIGITIZATION OF MINING LEASE BOUNDARIES HELD IN THE STEEL ROOM ON 2 ND AUGUST 2011.

The meeting was chaired by Shri Manoj Ahuja, I.A.S., Commissioner-cum-Secretary to Government, Steel & Mines Department. The following decisions were taken.

 Maps of Digitization will not be handed over to any lessee till the certified cadastral maps are made available from DoLR and the maps are validated. ORSAC should await instructions from the Government.

(Action: ORSAC)

 Director of Land Records will be requested to provide certified cadastral maps of Keonjhar, Mayubhanj and Jajpur districts. Revenue and DM Department to start digitization of maps in Sundargarh district.

> (Action: Director of Mines/ DoLR / Revenue & DM Deptt.)

 Updated status of all leases related to iron, manganese and chromite in Joda, Koira, Keojhar, Jajpur Road & Baripada circles will be maintained inrespect of area, status of application for digitization (applied/not applied), completion of DGPS survey (completed/under progress/to be taken up), receipt of lease boundary map (received/not received), overlapping difference between boundary pillar DGPS survey and geo referenced digitized ML map cross checked with the reference point, if any and status of Total Station Survey (completed/not completed).

(Action: Nodal Officer & ORSAC)

The DDMs and MOs of Joda, Koira, Keonjhar, Jajpur Road and Baripada will make a list of all reference points mentioned in all lease boundary maps in their circles on priority basis in the first phase within 15 days.

(Action: DDM/MO, Joda, Koira, Keonjhar, Jajpur Road)

 The chief surveyors/surveyors of respective circles, in consultation with the Tahsil staff of the area will check the physical presence of these reference points in the field.

(Action: DDM/MO, Joda, Koira, Keonjhar, Jajpur Road)

 Wherever reference points mentioned in the leasehold maps are not available in the field help of the Revenue Department will be taken to relocate these.

(Action: DDM/MO, Joda, Koira, Keonjhar, Jajpur Road)

 Finally the co-ordinates (Latitude & Longitude) of each of the reference points will be collected using hand held GPS sets by the Surveyors of the respective circles and the data so obtained will be passed on to the Nodal Officer for onward transmission to ORSAC.

(Action: DDM/MO, Joda, Koira, Keonjhar, Jajpur Road)

 Collectors of Keojhar, Sundargarh, Jajpur and Mayurbhanj will be requested to co-ordinate the work between the officials of revenue department and circle mining offices so that the job of recording the coordinates and providing the data for geo-referencing of lease maps will be completed within one month.

(Action: Steel & Mines Department)

 Secretary, Revenue Department will be requested to render necessary help and issue instructions in this regard.
